What documentation do I need to import from Nicaragua?

To import into Nicaragua, an importer must present the following documentation to the Nicaraguan Customs Authority (DGA): permits issued by Nicaraguan authorities (if necessary), certificate of origin (to determine applicability of CAFTA-DR and other trade agreements). Importers must also register as a taxpayer with DGI.

Does Nicaragua have a customs agreement?

Under the agreement, Nicaragua must promptly publish its customs measures, including on the Internet. The agreement also requires Nicaragua to release goods from customs promptly and to clear express shipments expeditiously, although businesses report arbitrary delays and fines.

How can I get information about customs regulations in Nicaragua?

Do importers need a customs broker in Nicaragua?

Importers must use the services of a licensed customs broker.
