Does Spain have a regulatory framework for energy storage?

Spain's regulatory framework does not address energy storage systems, with the exception of pumped hydro, which is considered a conventional generation system, and thermal storage associated with thermal solar power plants.

Can a TSO own a energy storage facility?

The EU Electricity Directive 2019/944 states that TSOs and DSOs cannot own, develop, manage or operate energy storage facilities because it's a market-based and competitive activity; except if a derogation is given by the NRA in very specific conditions.

What is energy storage?

'energy storage' as the electricity system, deferring the final use of electricity to a moment later than when it was generated, or the conversion of electrical energy into a form of energy which can be stored, the storing of such energy, and the subsequent reconversion of such energy into electrical energy or use as another energy carrier.
