

Does a solar inverter have a warranty?

Most solar inverter manufacturers leave workmanship (labor) warranties to the installer. Still,like labor and shipping costs,some manufacturers offer an extra safeguard by tacking on their own workmanship warranty coverage. When applicable,it's typically only an option if you work with specific installers in a manufacturer's certified network.

How long is a power inverter warranty?

Usually,inverter manufacturers offer a standard warranty period of 10 yearsfor string inverters,whereas module-level power electronics (MLPEs) like microinverters or power optimizers offer 25-year warranties. In the case of an extended warranty period,few manufacturers allow you to purchase extra warranty time for their products.

Are labor and shipping costs included in solar inverter warranties?

Labor and shipping expenses are generally not included in solar inverter warranties, but some of the strongest brands will cover one or both of these costs. Based on our ranking system, Hoymiles, Solar Edge, Tigo, SMA, and Enphase have the strongest warranties.

How do I apply for a solar inverter's warranty claim?

If you're planning to apply for a solar inverter's warranty claim, the process might vary depending upon the manufacturer, and it is important to follow these steps: Check that your warranty is registered with the manufacturer during the installation. Identify the issue by detecting the error codes on the inverter's display to identify the issue.

Are solar panels covered under warranty?

If you are within the warranty period, this may be free. Problems with the solar panels themselves, or any associated equipment such as batteries and inverters, are likely to be coveredby the associated product or performance warranty during the warranty period. Contact your solar retailer or installer in the first instance.
