The solar PV system was placed in service between January 1, 2006 and December 31, 2023. The federal solar tax credit, also known as the solar Investment Tax Credit (ITC), is a commercial solar incentive that reduces your federal income tax liability by a percentage of your solar installation costs. The federal solar tax credit in 2023 is worth 30% of your solar installation costs and will be available from 2022 until 2032.
